
The following three persons should be included by the LLC as its non-statutory co-opted member for its effective functioning:

- **District Social Welfare officer/District Disabled Welfare Officer** - The DSWO will ensure convening of LLC meeting regularly, smooth functioning of LLC, **maintenance of records in the custody of District Magistrate.**
- **Civil Surgeon** - The Civil Surgeon will ensure the credibility of the issuance of guardianship certificate in respect of a-person with disability, he/she requires a guardian or not.
- **Senior Lawyer** - The Lawyer will ensure bona-fide of the applicant on documentary evidence.

The Local Level Committee shall implement the relevant provisions of The National Trust Act & Rules, Regulations made there under.
