1. Name of the Organisation will be JEEVAN.
2. Registered Office of the Organisation will be situated at Bastacolla, Gawsala Road, P.O. Dhansar, P.S. Jharia, Dist. Dhanbad.
3. Assets and Liabilities :
This organisation takes up all the assets and liabilities previously registered in undivided Bihar bearing name JEEVAN and Registration No. 88 of 1996-1997. Certified that this is the true correct copy of the Rules and Regulations of the Society JEEVAN.
4. The main objectives for which the organisations is established are :
 - i) To encourage guede people for opening the cottage industry of village based industry.
 - ii) To encourage them for social forestry, fisheries, poultry and to acknowledge and one regarding other government programmes.
 - iii) To teach the people through evening classes and through other mass media regarding health problems, educational hazards, and other social economical problems.
 - iv) To teach the people about then need and gains of family planning.
 - v) To teach the people for better utilization of waste product as the fertilizer fuling.
 - vi) To teach the people and to help them after giving them come technical know how and some medicines for SAVE GRAIN CAMPAIGN.
 - vii) To open village library, cultural and for providing job oriented training like sweing, typing etc. for handicapped.
 - viii) To conduct research and survey and survey for handicapped purposes.
 - ix) To fix, demand the gee grants and other charge as may be laid down in the rules of the association.
 - x) To offer scholarship, prize and stipened to unfluence the objectives of the organization.
 - xi) To collaborate and take held from the institution of India and abroad having objects wholly or partly similar to our organisation.
 - xii) To organised job oriented vocational rehabilitation centre for the handicapped and poor man and woman and all the Harijans.
 - xiii) To provide residential facility to the needy or helpless individuals getting treatment in our clinic.
 - xiv) To discource beggars from begging after providing some economical assistance for starting the livelihood.
 - xv) To encourage the people for social forestry.
 - xvi) To undertake all such project to be acilitated by the ministry of environment and pollution.
5. Persuant to be aforesaid objectives the organisation may :-
 - a) Accept recurring and specific grants of money, securities or property of any kind moveable or immoveable.
 - b) To invest and deals with the funds and money of the organisation.

- (c) Purchase, hire, take on lease, exchange or otherwise acquire , property moveable or immoveable which may be necessary, or convenient, for the purpose of the organization any construction, alteration or maintain such building such building and work as may be necessary , for carrying out the objectives of the organization.
- (d) Sell, hire, lease exchange or otherwise transfer or dispose off all or in a part to any property of the organization moveable or immoveable.
- (e) Borrow and raise money on mortgage.
- (f) Operate reserve funds, sinking funds, Insurance fund or any other insurance funds or depreciation repair, improvement, extension, maintenance of any of the property, or right of the association and /or recouping wanting assets and for any other purpose for which the organization seems inexpedient or proper to create or maintain any such funds.
- (g) All property of the organization shall vest in the executive committee which will be headed by the president.
- (h) The Income and property of the organization how ever derived shall be applied towards the promotion of the objectives as set forth in the memorandum of the organization, never the less in respect of the expenditure and grants made by the member to such direction as executive committee may from time provide.
